Full wording of the Objects (charitable aims) of the organisation are in our Memorandum & Articles of Association (see documents section of our website).

Broadly speaking, they are:

Advancing community development, rural regeneration, education, arts, culture, recreational facilities, environmental protection and relief of those in need due to disadvantage, within Assynt.

The organisation may by resolution in a General Meeting change these membership fee amounts, which may then be different for different categories of membership. If so, members will be notified of the resolution to change, ordinary members may vote on the resolution to change, and members will be notified of any change, and may then choose to cease their membership if they wish. (Membership can anyway be ended by a member at any time.)

Late payment may by discretion be acceptable to ADT. Payment above the required amount is welcome, as a donation towards our work. Payment for multiple years in advance is welcome, although at the member's risk, in the case of future years of membership not coming to pass for any reason.
